

PRIVACY NOTICE

1. Introduction

Global Disability Innovation Hub ("we" "us", or "our") respects your privacy and is committed to protecting your personal data.

Please read this Privacy Notice carefully – it describes why and how we collect and use personal data and provides information about your rights. It applies to personal data provided to us, both by individuals themselves or by third parties and supplements the following wider <u>UCL privacy notice(s)</u>:

- General privacy notice when you visit UCL's website
- Student privacy notice
- Staff privacy notice
- Research participants for health and care purposes privacy notice

We keep this Privacy Notice under regular review. It was last updated on 27 August 2020

2. About us

GDI Hub Academic Research Centre is part of the UCL Interaction Centre at University College London (UCL).

UCL, a company incorporated by Royal Charter (number RC 000631), is the entity that determines how and why your personal data is processed. This means that UCL is the 'controller' of your personal data for the purposes of data protection law.

3. Personal data that we collect about you

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you. This may include:

- · Your name and contact details;
- 'Special category' data about you (this may include details about your race or ethnicity, religious or philosophical beliefs, sexual orientation, political opinions, trade union membership, information about your health etc.);

- The names and other details about third parties who are involved in the issues we are helping you with; and
- · Records of your electronic submission;

4. How we use your personal data

We will only use your personal data and submission information when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- To register you as a client and to manage our relationship with you.
- To help you with your enquiry. Depending on the circumstances, this may include special category personal data. Here, the processing of your information is carried out on the basis of your explicit consent; or
- We will use the information collected in this survey to:
 - o Produce a report, including a summary of the ideas submitted, which will be published and made publicly available.
 - Inform investments on AT by the AT Impact Fund under the AT2030 Programme.
 - o Inform IRCAI's work programme after its official launch in October 2020.
 - We would like to invite a small number of respondents to attend an online roundtable event in October. Please let us know if you would like to be considered for this and provide your contact details.
 - We would like to share the findings of this survey with all those who have contributed ideas. If you would like to receive notification of the report when it is published, please provide your contact details at the end of the survey

Where the processing is based on your consent, you have the right to withdraw your consent at any time by contacting us using the details set out below. Please note that this will not affect the lawfulness of processing based on consent before its withdrawal.

We may also use anonymised data, meaning data from which you <u>cannot</u> be identified, for the purposes of:

- Service evaluation;
- Education and research; or
- Fundraising and promotional purposes.

Anonymised data may also be used in published reports or journals and at conferences.

5. Who we share your personal data with

Your personal data will be collected and processed primarily by our staff and UCL (Access to your personal information is limited to staff who have a legitimate need to see it for the purpose of carrying out their job at UCL.). We may have to share your personal data with the parties set out below for the purposes outlined in section 4:

- UNESCO IRCAL
- European Disability Forum
- The Jožef Stefan Institute

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third party service providers to use your personal data for their own purposes – we only permit them to process your personal data for specified purposes and in accordance with our instructions.

6. Lawful basis for processing

Data Protection Legislation requires that we meet certain conditions before we are allowed to use your data in the manner described in this notice, including having a "lawful basis" for the processing. The basis for processing will be as follows:

- Consent. You have given us your consent for processing your personal data.
- Public task. The processing of your personal data may be necessary for the
 performance of a task carried out in the public interest or in the exercise of official
 authority vested in us [Note: read UCL's <u>Statement on Public Tasks</u> to ensure
 that your processing falls within scope of this condition]
- Legitimate interests. The processing of your personal data may be necessary for the
 purposes of the legitimate interests pursued by us or by a third party, except where
 such interests are overridden by your interests or by fundamental rights and
 freedoms which require protection of personal data [Note: read UCL's guidance on
 legitimate interests]

7. International transfers

We do not transfer your personal data outside the European Economic Area (**EEA**).

8. Information security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. We have established procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

9. Data retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

We will keep your personal data according to the Records Retention Schedule.

10. Your rights

Under certain circumstances, you may have the following rights under data protection legislation in relation to your personal data:

- Right to request access to your personal data;
- Right to request correction of your personal data;
- Right to request erasure of your personal data;
- Right to object to processing of your personal data;
- Right to request restriction of the processing your personal data;
- Right to request the transfer of your personal data; and
- Right to withdraw consent.
